Background

Deen Dayal Upadhyaya State Institute of Rural Development Bakshi Ka Talab, Lucknow (DDUSIRD-UP), an apex training Institute under Rural Development Department, Government of UP invites e-expression of interest from reputed training providers accredited & affiliated with Construction Skill Development Council of India to provide training for Rural Masons for construction of house under PMAY-G.

PMAY-G aims to provide a pucca house with basis amenities to all houseless and household living in kutcha and dilapidate house by 2022 and ensure construction of quality house. The house shall be constructed or got constructed by the beneficiary himself/herself under PMAY-G.

Scope of Work

The work involves providing largely on the job training and facilitating assessment of candidates at selected PMAY-G sites (house-cum-on the job training sites) as per the Rural Mason Qualification pack approved by National Skill Development Council (NSDC).

The Training Providers may also need to provide necessary reading material in local language required for training. The medium of instruction for the training and the reading material shall be in Hindi, preferably with local dialect. The training course shall be delivered based on an approved building design, contents and schedule approved by the competent authority. The trainers/demonstrators should be certified (as per MoRD, GoI guidelines for the Rural Mason QP in the construction sector), CSDCI certified (or certified from any agency/institution etc. recognized as per guideline of the MoRD, GoI) and eligible for imparting training to Rural Masons as per the prescribed QP-NOS. The lead trainers/supervisor to be deputed shall also be qualified (as per MoRD, GoI guidelines or the Rural Mason QP in the construction sector), CSDCI certified (or certified from any agency/institution etc. recognized as per the guidelines of the MoRD, GoI), eligible and experienced in dealing/handling the similar jobs relevant to the training of Rural Masons and construction of houses. Certificate of same must be produced by the TP in their proposal.

The training module for the Rural Mason Qualification pack is for an estimated training duration of 45 days per person considering 8 hours of work per day. However, additional days may be considered for very difficult terrains, prevailing local conditions etc. based on the assessment of the state.

At each house-cum-training site 5 selected trainees (semi skilled persons) from the rural area shall be given training by a exclusive qualified certified trainer (as stated above) along with a supervisor who may be deputed for not more than 3 such training sites.

The training shall involve on-the-job/practical component (approximately 80%) and theory (approximately 20 %) with all the necessary tools and methods appropriate to the context.

Term and Conditions of e-Expression of Interest

1. The Term and condition details of Expression are available on the website www.etender.up.nic.in or www.sirdup.in of Deen Dayal Upadhyaya State Institute of Rural Development, Bakshi-Ka-Talab, Lucknow. It is compulsory to deposit a Demand draft of Rs 500/- **in favour of Director General, Deen Dayal Upadhyaya State Institute of Rural Development Bakshi Ka Talab Lucknow** to the office of **Director General, Deen Dayal Upadhyaya State Institute of Rural Development Bakshi Ka Talab Lucknow** on or before **1 pm of 4.01.2018**.
2. Expression of Interest form completed in all respect by the TP will be submitted online on website www.etender.up.nic.in. The EOI will be submitted in two parts. (In 1st Part of Technical details and 2nd part of financial details.)

The Training Partners fulfilling the technical term and conditions will be called for presentation on predefined template. The date of presentation and template will be communicated later on. Selection criteria will be based on marks obtained in Technical documents submitted and presentation done by T.P. The Financial document will only be considered if marks found satisfactory in Technical documents and Presentation made by T.Ps.

3. ***The TP must be accredited with National Skill Development Corporation (NSDC)/Construction Skill Development Council of India (CSDCI) /DGT (Director General Training for providing training to Rural Masons. The Work involves providing largely on-the-job training and facilitating assessment of candidates at selected PMAY-G sites (house-cum-on the job training sites) as per the Rural Mason Qualification Pack approved by National Skill Development Corporation (NSDC). The qualification pack required for the job profile of Rural Mesons will be as per guideline issued by MoRD, Gol.***
4. e-Expression of Interest must be submitted on e-tender website www.etender.up.nic.in on or before 2 pm of 04.01.2018.

5. The Expression of Interest shall be opened online at 4 pm on 04.01.2018 by the committee of DDUSIRD, Lucknow..
6. **The e-Expression of Interest must be submitted online and Earnest Money Deposit (EMD) in the form of Bank Draft of Rs 5,00,000 (Rupees Five Lakhs only) in favour of Director General, Deen Dayal Upadhyaya State Institute of Rural Development, Bakshi Ka Talab Lucknow should be deposited in original to the office of Director General, Deen Dayal Upadhyaya State Institute of Rural Development Bakshi Ka Talab Lucknow in original on or before 1 pm of 4.01.2018.**
7. District wise details action plan should be submitted with technical norms.
8. T.P. will be fully responsible for developing the training schedule to cover the Rural Meson QP within 45 working days @ 8 hrs/day.
9. The medium of instruction shall be Hindi and expected delivery also in regional dialects where it is a necessity to the trainees.
10. Daily Training Report and Progress Report with onsite photographs with date and time should be sent to DDU-SIRD-LKO.
11. The TP shall not appoint or authorize any franchise (s) for important training assigned to them. If such complaints found then the TP may be black listed and the work given to them shall be withdrawn.
12. The successful Training Provider will have to deposit Security Money @ 5 % of the total work order in the form of FDR / Bank Guarantee in favour of Director General, Deen Dayal Upadhyaya State Institute of Rural Development, Bakshi Ka Talab, Lucknow.
13. The Training Provider will have to submit Registration certificate of Income Tax along with Expression of Interest document.
14. The Training Provider will have to submit photocopy of audited Balance sheet of last 3 years with Income Tax Return along with Expression of Interest.

15. The Training Provider will have to attach TIN / GST Registration certificate along with Expression of Interest document.
16. The Training Provider will have to bring original Income Tax certificate at the time of opening of envelop for verification.
17. The Payment term for the successful Training Provider in Expression of Interest will be determined by the recommendation of monitoring committee only after completion of assigned training.
18. The contract of Expression of Interest will be valid till 31st March, 2018.
19. In case of work not satisfying the standard of guideline of Rural Masons Training under Pradhan Mantri Awas Yojna-Gramin, Gol during any stage of implementation of the contract, Competent Authority/DDUSIRD-UP reserves the right to cancel the contract by providing a notice of 10 days.
20. Director General, DDUSIRD reserves the right to reject any or all the applications at any stage of the selection procedure without assigning any reason thereof.
21. TP will also be responsible for facilitating assessment by way of requesting DGT/CSDCI/NSDC to appoint qualified and certified assessors and provide the necessary infrastructure and material for assessment. The assessment will be done through CSDCI Assessment bodies (or through any assessing body (s) recognized as per the guidelines of the MoRD, Gol. The assessing bodies have assessors located in the Uttar Pradesh State. The Training Provider shall not be an assessing body.
22. The state authority reserves the right to assign targets and allotment and they should preferably have assessors located in the Uttar Pradesh State.
23. Financial, training norms, terms & conditions etc. shall be as per the guidelines of the MoRD, Gol as & when amended.

24. In cases of any dispute arising from the Training program, contract etc., the area of jurisdiction will be Lucknow.
25. The successful TP will have to sign a contract agreement with the competent authority.
26. After submission of Expression of Interest document by TP, will be assumed that the TP accepts all the term and conditions.
27. The rate of contract for successful Expression of Interest will be valid from the date of contract to 31st March 2018. This date can be extended by competent authority, if necessary.
28. **The decision taken by DDUSIRD-UP in any case will be final.**

(Financial)

I/ We have gone through the documents and understand the work/term and conditions of Expression of Interest published in advertisement No..... dated.....by Director General, Deen Dayal Upadhyaya State Institute of Rural Development, Bakshi-Ka-Talab, Lucknow and accept all the term and conditions described in the document.

The Cost paid to the training providers as per the Uniform Cost norms laid out by the Government of India, with the current ceiling @ Rs. 38.50 per trainee per hour (subject to maximum 360 hours to cover all the contents of prescribed QP-NOS for rural mesons and any other contents, if included). In the case of rural mason training funded by MoRD and RD department of Government of Uttar Pradesh, besides the cost of providing actual training, this ceiling includes making available the required training infrastructure and common tools, provision of training materials, and facilitating assessment of trainees by an assessing agency accredited with DG(T) Ministry of Skill Development and Entrepreneurship, Gol/CSDCI/NSDC by qualified/certified assessors as well as certification and placement of trainees.

Mobilization of potential trainees will be undertaken by the local administration and the TP is expected to lead the process of pre-screening. Cost of raw materials for on the job training will be borne by the PMAY-G beneficiary whose house is being constructed through the process however the TP is expected to assist the beneficiary in selection of materials of acceptable quality in line with the bill of quantities approved for the house. Any common tools required for the training will be made available by the T.P.

Training of 20,000 Rural Masons under PMAY-G is proposed to be completed till 31st March 2018. (The figure of trainees may increase or decrease as per requirement). According to the term and conditions of Expression of Interest, District wise implementation plan, rate / amount with all taxes details of amount is as follows:
